Parent Q & A

Dr. García's latest community update: March 23rd Update

1. Will there be online school and how will grades be impacted?

Answer: The district will not have a specific online school. Parents and students may access optional learning activities on the district website under the Student Learning Activities tab. These activities are intended for practice, enrichment and maintenance of skills already taught. These activities are not mandatory and will not impact a student's grade.

2. How will the school closure impact semester grades if no assignments during the closure are graded?

Answer: Grades are currently frozen and will not change until schools reopen.

3. How will children who might have a less-than-ideal grade in a class at this time have an opportunity to improve that grade? For kids who are high school juniors that need every week of the semester to work on getting the highest grades possible for college admissions, this is an important question.

Answer: At this time grades are frozen. When schools reopen, students will have opportunities to improve and remediate grades as currently practiced.

4. I see that the assignments aren't graded in the resource section. Does this mean that the end of the school year is extended for grades 9-11 for as long as many weeks as school is closed? How about the seniors? We will need to plan if the seniors are actually going to be able to graduate (not walk, but complete the requirements) for college beginning in late august.

Answer: At this time, extension of the school year is unknown. We continue to await guidance from the state on graduation and credit requirements. With this international pandemic, we are optimistic that systems will work together to ensure positive outcomes for all students.

5. Will the school closing affect the length of summer break? Will the students have to make up these lost days?

Answer: At this time, the impact on our school calendar is unknown. While the state has waived the number of mandatory days in the school year, we do not know the specific impact yet.

6. Will this time need to be made up at the end of the school year for students to stay on track with the necessary learning for this school year? if not, is there a period of time that would need to be made up if the closure extends? Thanks for keeping us all safe and stay well.

7. Will students be required to make up the time they are missing now because of the school closure in the summer? Will this extend the school year past June 10th?

8. Using the current proposed return date of April 13th, does it appear that the school year will be extended past the current end date June10th?

How will the school hours be made up? Will the school year be extended into the summer (hopefully)

13. Are all athletic and VAPA (Visual and Performing Arts) events cancelled?

Answer: Yes. All games, matches, events, practices, and rehearsals have been cancelled until further notice.

14. How long will our schools be closed?

Answer: Currently, our schools will be closed from March 16th through April 10th. This date may be extended depending on CDC and/or state directives. We will provide families with updates as they are received.

15. Are campuses open to parents, students and/or volunteers during school closures?

Answer: No. All SMUSD campuses are closed. Grab and Go lunches will be distributed during the designated time.

20. Are schools being cleaned while they are closed?

Answer: Our custodial staff is working diligently to keep our schools clean. They will be working throughout the school closures to prepare for students to return to campus.

21. Will school be extended past June 10 or will June 10th still be the last day of the school year? Thank you.

22. Is there any chance you will move to online learning of some sort? I understand tech issues with some families but it seems those are solved with the chromebooks and free wifi. Lots of districts are doing this. I understand it is challenging but for high school students, particularly those in AP classes, the learning activities provided on your site are simply not enough to keep them learning or to prepare them for their tests. It isn't right to keep all kids from learning just because of these issues. Thanks.

Answer: The District is considering various options to support our students' learning. As soon as our plans are solidified we will be sharing them with the community.

23. With the recent announcement from Governor Newsom that he doesn't believe schools will reopen before summer, how are you planning on having students complete this academic year?

Answer: Although Governor Newsom announced his opinion that schools will not reopen before summer, he has not authorized the closing of schools for the remainder of the year. Future information from the state will guide our actions regarding the completion of the academic year.

24. Will the school year be extended because of this shutdown?

Answer: See answer to question 14.

25. How can I get a hold of my daughter's counselor?

Answer: You may email the counselor as staff are working from home during school closures.

26. In order to not lose credits and maintain future learning, will the district consider waiving its requirement that all core HS classes be taken at the district so that students may take math, history, etc. via virtual schools and continue their academic progression?

Answer: This may be a consideration as we explore various options to support student learning during the time of school closures.

27. With the current crisis, many of us parent are being required to work from home. Our work responsibilities have not changed, and we still have to get our work done. With this in mind, why can't the San Marcos school teachers work from home also? They can

still post assignments, grade papers, post video lectures etc.. Even if the assignments are not for an actual grade, it would still keep the kids on track, learning, and ready for the next school year. Links to online content separate from school is all good, but that does not explain why the teachers cannot continue to do their assigned work within the school system (I assume, rightfully, that they are still receiving full pay and benefits). By the way, some have taken it upon themselves to do this informally which is very commendable, but it should be a blanket policy in order to keep things rolling. Other school districts in the area are doing this, so San Marcos kids should not be left behind!

CVUSD And nearby school districts already distance learning for high school (including AP/IB coursework) beginning the week of Monday, March 23rd. Our children need the same opportunity for high-quality learning.
